SEEKING EXPRESSION OF INTEREST FOR EMPANELMENT OF RESOURCE PERSONS

Purpose: Extending support in Developing, Designing and Conducting need based Training to State Rural Livelihoods Mission (SRLM) staff and members of Self Help Groups (SHGs), Village Level Organisation (VLOs) and Cluster Level Federation (CLFs).

Nagaland State Rural Livelihoods Mission (NSRLM) is the nodal agency created by the Government of Nagaland to implement DAY-NRLM in the State. Detailed information on NSRLM is available in the website www.nsrlm.nagaland.gov.in. Seeing the magnitude of the capacity building and training required by the dynamic nature of the State Mission, NSRLM intends to seek services of competent and experienced professionals as “Resource Persons” on need/call basis. The Person should have profound understanding on Dimensions of Poverty, Social-Economic-Cultural issues, Gender issues, Livelihood, and Market Linkage in the context of Nagaland.

The detailed *desired qualifications, experience and services* of Resource Persons is downloadable “**Policy on State Resource Person**” document from the website. The tasks will be steered by the HRD unit of NSRLM and nodal persons for this entire assignment would be the thematic head at the State Office. Empaneled resource persons are expected to deliver required services in close coordination with the nodal persons. The resource persons will be empaneled purely on the basis of quality of relevant working experience, education and length of services in the development sector. Empanelment of Resource Persons will solely be done on assignment basis and co- terminus with the objectives once fulfilled or decision as taken by NSRLM management with/without citing any reasons. The services of resource person will be sought on call and rotation basis, as and when required, but not exceeding 60 working days in a year. Service fee (as per NSRLM norms) on the basis of per day service will be paid to the empaneled resource persons. In case of travel, expenses will be reimbursed as norms applicable in NSRLM. The State Mission may like to send empaneled resource persons to place/institution (within/outside state) for exposure or better learning.

Interested candidates meeting the eligibility criteria may submit expression of interest in the form of a covering letter with (i) Latest CV in prescribed format only; and (ii) a write up (in English only and not exceeding 300 words) on “Why do you think you are suitable for the required assignment?” latest by 31st July 2022 through email only to nsrlmhr2020@gmail.com . Expression of Interest without covering letter or CV not in prescribed format or not attached with required write-up will be rejected. Communication received other than prescribed email will NOT be entertained.
